ICYMI: INFORMATIONAL WEBINARS

This month, SCWA hosted 3 webinars covering topics relevant to choice schools. See below for a quick summary of each and link to the webinar recording.

6/5 – ECCA 2025: The Educational Choice for Children Act of 2025 is a federal bill that would provide donors to nonprofit groups that distribute K-12 scholarships with a dollar-for-dollar federal tax credit in exchange for their contributions. National leaders discuss what this would mean for private schools in Wisconsin if enacted.

6/13 – Act 20 (Literacy Promotion Policy): As of July 1, 2025, schools must have a written plan outlining their 3rd to 4th grade promotion policy that considers a child's reading ability. The Wisconsin Institute for Law & Liberty (WILL) provides recommendations for how schools can comply with the state's requirements while implementing best practices.

6/19 – Act 12 (Crime Reporting): Each year, schools with grades 9-12 must complete their annual legal reporting requirement for state and local law violations that occur on school property. WILL attorneys walk through what exactly the law requires and share a clear and straightforward process for compliant reporting.
